It was moved by Ms. Peter, seconded by Ms. Shelton, and carried to approve the Minutes of the February 24, 2016 Administrative Appeals Committee Meeting.

Mr. Davis noted the necessity of closed session for the purpose of reviewing the administrative appeals of Administrative Action Numbers: 15-A-02, 15-PS-15, 15-A-15, 15-T-03 and 15-A-18.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Ms. Peter, seconded by Ms. Shelton, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 15-A-02, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to deny claimant's request for appeal relief.

It was moved by Ms. Shelton, seconded by Ms. Peter, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order of Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 15-T-03, to accept the Hearing Officer's Order of Dismissal and to dismiss Kentucky Retirement Systems administrative action and continue the claimant's disability retirement benefits.

It was moved by Ms. Peter, seconded by Ms. Shelton, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order of Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 15-A-18, to accept the Hearing Officer's Order of Dismissal and to dismiss this administrative appeal under the language set forth in the parties Agreed Order to Dismiss Action, as there being no justiciable controversy between the parties and the matter now moot.
