It was moved by Ms. Hook, seconded by Ms. Peter, and carried to approve the Minutes of the June 22, 2015 Disability Appeals Committee Meeting.

Mr. Davis noted the necessity of closed session for the purpose of reviewing the disability applications of Administrative Action Numbers: 11-D-161, 14-D-59, 14-D-52, 14-D-70, 14-D-41, 14-D-80, 14-D-62, 13-D-111, 14-D-60, 14-D-08, 07-D-17, 14-D-74, 14-D-88, 14-D-97 and 13-D-105.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Ms. Hook, seconded by Ms. Peter, and carried unanimously, that the Committee members having considered the record, including the recommended order on remand and any exceptions duly filed, in the case of Administrative Action Number: 11-D-161, to accept the Hearing Officer's Report on Remand, Findings of Fact, Conclusions of Law, and to approve claimant's application for disability retirement benefits, with review in two years.

It was moved by Ms. Peter, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-70, to remand this matter to the hearing officer, pursuant to its statutory authority in KRS 13B.120(2), with instructions that Claimant undergo a comprehensive Independent Psychological Evaluation (IPE) with Dr. Paul Ebben, Psy.D with Insight Psychological Consultants, PSC. The results of that evaluation shall be submitted as evidence and made part of the administrative record of this matter. The Systems shall bear the cost of this evaluation. Upon completion, the Hearing Officer shall entertain requests by the parties to submit additional evidence and/or additional briefing, as needed. Thereafter, the hearing officer is ordered to promptly issue Findings of Fact, Conclusions of Law and Recommendation on Remand on whether disability benefits should be approved.

It was moved by Ms. Hook, seconded by Ms. Peter, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-41, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's application for duty-related disability retirement benefits.

It was moved by Ms. Peter, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-80, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to approve claimant's application for hazardous disability retirement benefits based upon the condition of cardiomyopathy under KRS 16.582(1)(b), with review in one year. In addition, the Board hereby issues its Final Order denying claimant's application for hazardous disability retirement benefits based upon the bilateral knee conditions and in the line of duty disability retirement benefits under KRS 16.582(6) and KRS 16.505(19).
