It was moved by Ms. Peter, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 13-D-114, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's application for disability retirement benefits.

It was moved by Ms. Hook, seconded by Mr. Davis, and carried by a majority, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 13-D-69, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to deny both the claimant's application for disability retirement benefits and her application for duty-

related disability retirement benefits. Ms. Peter dissented.

It was moved by Mr. Davis, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 12-D-137, to remand this case to the hearing officer. The claimant in this matter has less than sixteen (16) years of service credit, and the issue of possible pre-existing conditions was properly raised during the administrative process. The hearing officer's recommended order, however, failed to address pre-existing causation. Therefore, the hearing officer is hereby ordered to consider the issue of pre-existing causation in this case and make corresponding Findings of Fact and Conclusions of Law. Once this has been accomplished, the hearing officer is then ordered to promptly issue a Recommended Order on Remand in order to minimize any further delay to the parties.

There being no further business, the meeting was adjourned at 11:25 A.M., E.T. to meet on April 24, 2015 at 9:00 A.M., E.T.
