It was moved by Ms. Shelton, seconded by Mr. Lang, and carried to approve the Minutes of the January 23, 2017 Disability Appeals Committee Meeting.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications of Administrative Action Numbers: 16-D-13, 16-D-35, 16-D-03, 15-D-36, 15-D-82, 15-D-101 and 15-D-92.

Mr. Lang dissented.
