It was moved by Ms. Hook, seconded by Mr. Summers, and carried to approve the Minutes of the September 28, 2015 Disability Appeals Committee Meeting.

Mr. Lang noted the necessity of closed session for the purpose of reviewing the disability applications of Administrative Action Numbers: 14-D-93, 14-D-109, 14-D-30, 14-D-81, 14-D-95, 14-D-72, 15-D-06, 14-D-43, 14-D-73, 14-D-57 and 15-D-55.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Mr. Summers, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-93, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's application for disability retirement benefits.

It was moved by Ms. Hook, seconded by Mr. Summers, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-109, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to approve claimant's application for disability retirement benefits, with review in four years.

Mr. Bowman recused from participation because of prior involvement in this matter.

It was moved by Mr. Summers, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-95, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to deny claimant's application for hazardous in-line-of-duty disability retirement benefits.

It was moved by Ms. Hook, seconded by Mr. Summers, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-72, to reject the Hearing Officer's Report to deny hazardous disability retirement benefits and to instead, issue a Board of Trustees Order, approving claimant's application for hazardous disability retirement benefits, with review in three years.

It was moved by Mr. Summers, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 15-D-06, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's application for disability retirement benefits.

It was moved by Mr. Summers, seconded by Mr. Lang, and carried by a majority, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-43, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's application for disability retirement benefits and non-hazardous duty-related disability retirement benefits. Ms. Hook abstained.

It was moved by Ms. Hook, seconded by Mr. Summers, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-73, to accept the Hearing Officer's Report, as modified in the Board of Trustees Final Order, and to deny claimant's application for disability retirement benefits.

It was moved by Mr. Summers, seconded by Ms. Hook, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-D-57, to reject the Hearing Officer's Report to deny disability retirement benefits and to instead, issue a Board of Trustees Order, approving claimant's application for disability retirement benefits based on cumulative effect of her conditions, with a review in four years. Mr. Bowman recused from participation because of prior involvement in this matter.

The Board, having reviewed Claimant's Motion to Strike Exceptions filed by Kentucky Retirement Systems, overrule Claimant's Motion.

It was moved by Ms. Hook, seconded by Mr. Summers, and carried unanimously, that the Committee members having considered the record, including the default recommended order of dismissal and any exceptions duly filed, in the case of Administrative Action Number: 15-D-55, to accept the Default Recommended Order of Dismissal and to dismiss claimant's disability appeal action, at the request of the Claimant.
