At the meeting of the Administrative Appeals Committee, held on September 19, 2016, the following members were present: Keith Peercy, Chair, Vince Lang and Donna Shelton, Proxy on behalf of Thomas Stephens.

In addition, those present were Becky Stephens, KRS, Liza Welch, KRS, Joseph Bowman, KRS, Alan Hurst, KRS and Tracy Chambers, Recording Secretary.

It was moved by Mr. Lang, seconded by Ms. Shelton, and carried to approve the Minutes of the July 18, 2016 Administrative Appeals Committee Meeting.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the administrative appeals of Administrative Action Numbers: 15-PS-16 and 14-A-05.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Ms. Shelton, seconded by Mr. Lang, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 15-PS-16, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to deny claimant's appeal and affirming Kentucky Retirement Systems' determination that claimant is required to pay actuarial costs associated with the increase in creditable compensation pursuant to KRS 61.598.

It was moved by Mr. Lang, seconded by Mr. Peercy, and carried by a majority, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 14-A-05, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to deny claimant's appeal of Kentucky Retirement Systems' decision not to accept his untimely disability benefits application. Ms. Shelton abstained. Mr. Bowman recused from participation because of prior involvement in this matter.

There being no further business, the meeting was adjourned at 1:00 P.M., E.T. to meet on November 21, 2016 immediately following the Disability Appeals Committee meeting.
