At the meeting of the Joint Disability and Administrative Appeals Committees, held on August 30, 2021, the following members were present via live video teleconference: Keith Peercy, Chair, Betty Pendergrass, and Campbell Connell.

In addition, those present were Erin Surratt, KPPA, Victoria Hale, KPPA, Shaun Case, KPPA, Glenna Frasher, KPPA, and Lisa Perry, Recording Secretary.

It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried to approve the Minutes of the June 23, 2021 Joint Disability and Administrative Appeals Committee Meeting.

Mr. Case and Ms. Frasher departed the meeting prior to entering closed session.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications and administrative appeals of Administrative Action Numbers: 20-D-33, 19-D-53, and 20-D-47.

It was moved by Mr. Connell, seconded by Ms. Pendergrass, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 20-D-33, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to deny Claimant's application for disability retirement benefits.



It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order of Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 20-D-47, to accept the Hearing Officer's Order of Dismissal, and to dismiss this action with prejudice. Furthermore, the Claimant's Motion to Reconsider the Hearing Officer's Dismissal, is hereby denied due to the Motion having been untimely filed.


There being no further business, the meeting was adjourned at 9:45 A.M., E.T. to meet on October 25, 2021 at 9:30 A.M., E.T.
