CERS Reporting Changes Effective July 1, 2026

New Contribution Groups and Employer Contribution Record Layout

<u>Senate Bill 10</u>, passed during the 2025 Regular Session of the Kentucky General Assembly, includes changes that impact CERS members and employers.

As a result, Kentucky Public Pensions Authority (KPPA) created two new CERS contribution groups to capture the Tier 1 members with a participation date of July 1, 2003 – August 31, 2008, who will pay a Health Insurance Contribution (HIC).

The two new contribution groups will be CERS Non-Hazardous (CNHZDC) and CERS Hazardous (CHZDC) for Tier 1 Dollar Contribution members.

In addition, the Hazardous HIC rate will increase from one percent (1%) to two percent (2%) of creditable compensation for all hazardous contribution groups. See link for the new CERS Employer Contribution Record Layout.

The above HIC requirements will be effective for records reported with a July 1, 2026 posting date and after.

Note: The new HIC rate changes do not apply to members with a participation date between July 1, 2003 and July 31, 2004, **and** a hire date before July 1, 2003. A member newsletter will be released in January 2026 which will educate impacted employees on how to verify their participation dates in Member Self Service (MSS).

Summary of Employee Contribution Changes

To comply with new reporting requirements, employers will need to update payroll systems before submitting the July 2026 monthly report. The new contribution groups should **not** be reported prior to the July 2026 monthly report.
