

KERS Nonhazardous Employer Contribution Rate Fiscal Year 2019

Background

House Bill 265 passed during the 2018 legislative session reduced the employer contribution rate for Regional Mental Health/Mental Retardation Boards, Local and District Health Departments, State Universities, Community Colleges and any other agency eligible to voluntarily cease participating in the KERS.

Under the provisions of House Bill 265, the agencies listed below qualify to pay the reduced employer contribution rate of 49.47% (same as fiscal year 2018) for their KERS Nonhazardous employees for fiscal year 2019, effective July 1, 2018. Agencies not listed will pay the KERS Nonhazardous budgeted employer contribution rate of 83.43%.
