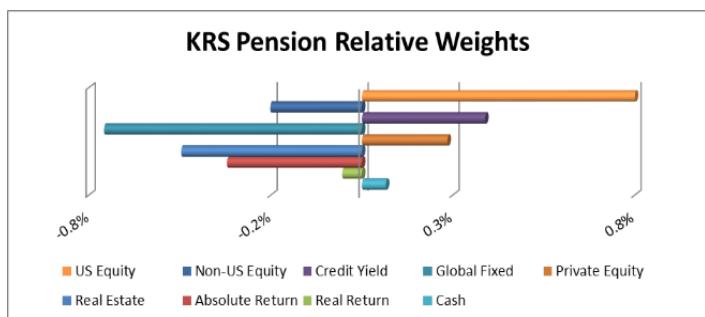
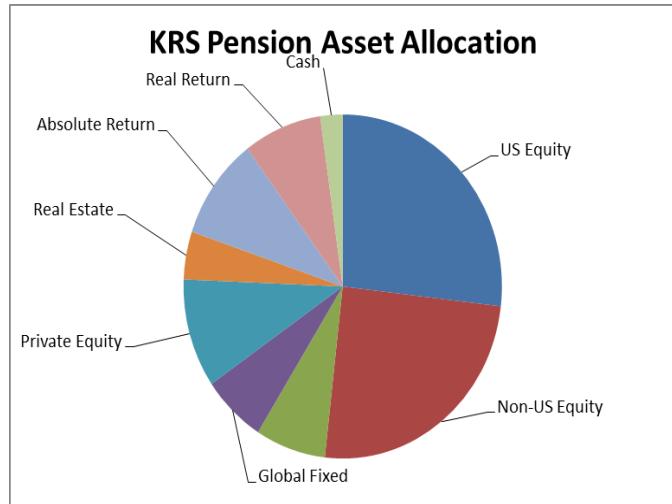


What's going on in the marketplace?

United States equity markets soared about 5% in November after the election of Donald Trump. The prevailing narrative is that lower corporate tax rates and less regulation will benefit domestic industry. Small cap equities saw enormous gains: 11.15% per the Russell 2000 Index. Mid cap equities followed with 8.01% (S&P Midcap Index) and large caps lagged both with a 3.70% monthly return (S&P 500 Index). It will be interesting to see how much momentum is behind the "Trump Rally" and if it can be supported by traditional fundamentals.

International stocks diverged from the United States. Emerging market were hit the hardest, losing 4.6% (MSCI Emerging Market Index). Developed international stocks fared slightly better, losing 1.98% (MSCI EAFE Index). In total, the MSCI ACWI ex USA Index returned -2.30% in November.

U.S. bond markets also displayed inverse correlation with U.S. equities in November. The Barclays U.S. Aggregate Index fell 2.37% for the month. High yield bonds fared better for the second straight month, with the Barclays U.S. Corporate High Yield index returning -0.47%.



What added value this month?

Pension- KRS Pension outperformed its benchmark both in the stock market and in the bond market while lagging in smaller asset classes. The plan gained 49 basis points on the month. A 49 basis point gain compares favorably to the benchmark gain of 28 basis points. Within equities, NTGI Structured and Systamatic led all managers with close to 10% return on the month. NTGI Structured's

performance came close to its benchmark, while Systamatic gained 3.6% relative to its benchmark. A notable fixed income manager once again was Marathon Bluegrass Credit Fund. They've outperformed their benchmark 5.6% on the year, including 2.17% outperformance on the month. In addition to manager selection, monthly relative weight levels benefitted the Pension portfolio overall. The most dramatic relative weights were US Equity and Fixed Income. US equity was overweight while Fixed Income was underweight. Since, in absolute terms, US Equity was the best performer and Fixed income was the close to the worst, this proved to be a dramatic benefit for the Pension plan. The underweight to Non-US equity also was a significant benefit.

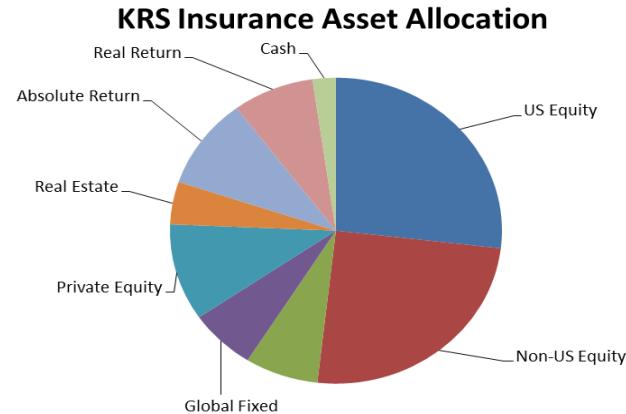
INSURANCE – The Insurance portfolio performed even better than the pension, adding 65 basis points in November. Public equity, especially U.S. equity, was the major driver. U.S. equities gained 5.31% while all equities gained 1.54%. Both of those gains bested their benchmarks. Many of the major notable manager performances mirrored the pension plan. Public Equity and Fixed Income were the bright spots relative to their benchmarks while Real Return, Real Estate, Absolute Return, and Private Equity slightly trailed. While manager selection for Insurance closely mirrored the Pension plan, relative weights were a different story. While Insurance did not have the same overweight to US Equity that the Pension plan did, it did have a more

significant underweight to Non-US Equity. Therefore the Insurance plan saw the same net positive effect due to relative weights that the Pension plan did, albeit for different reasons.

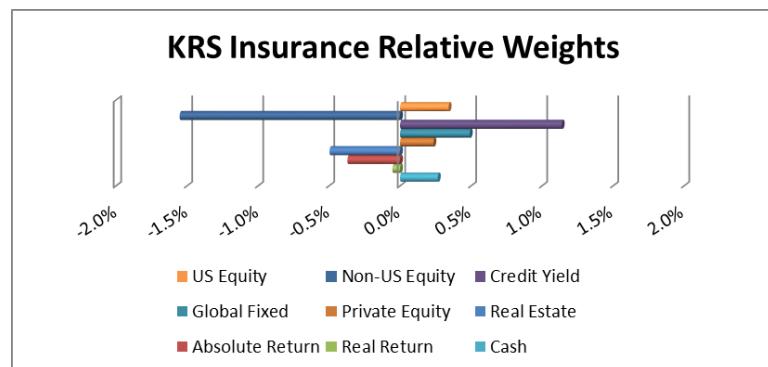
What detracted this month?

PENSION – The largest underperformance (31 basis points) due to KRS-specific managers came from the Absolute Return asset class. Real Return and Real Estate essentially matched their benchmarks coming within a few basis points.

No relative weights for the Pension portfolio detracted meaningfully. The only asset class that gained on the month yet was underweight was Absolute Return. However, its gains lagged the portfolio overall, and so an overweight would not have necessarily helped.



INSURANCE – Like in the pension portfolio, Real Return, Real Estate, and Absolute return asset classes underperformed their benchmarks. Real Estate underperformed its benchmark by 3 basis points, and Real Return underperformed its benchmark by 17 basis points. Underperformance by Absolute Return was more significant at 31 basis points. Also similar to the Pension portfolio, relative weights were not a detractor for KRS Insurance, as the 1.5% underweight of Non-US Equity significantly benefitted the portfolio. However, there were a few asset classes with relative weights that gave headwinds to performance. Namely, Private Equity was overweight but struggled. Absolute Return and Real Return weights also caused minor performance drags. Overall, a 65 basis point gain for Insurance for the month is strong at current risk levels.



NOTES:

- 1) Returns displayed are "net". For the purposes of this report, total fund return information is net of fees and expenses, with audited data beginning in July 2011. At the manager level (detailed return sheets pgs.4-5), returns are net of fees beginning with July 2011, and gross of fees for prior data.
- 2) Individual plan allocation and performance (pg.6).
- 3) Prior to January 1, 2014, the inception date for the Private Equity asset class was stated as 10/1/1990 for Pension Fund and 6/1/2001 for Insurance Fund. Prior to 07/01/02, the characteristics of the allocation, and the benchmark itself, were more closely aligned with Real Estate. As such, it is not appropriate to report this portion of the return stream within the Private Equity allocation, whose true inception date has been determined to be 07/01/02 based on funding the Systems' first private equity mandate. The portion of the original return streams that are no longer reported within the Private Equity allocation (Pension from 10/1/90 to 06/30/02; Insurance 06/01/01 to 06/30/02) are reported within the Fund Level performance figures.

- 5) The Private Equity Benchmark, from one month returns up until five year returns, is equal to the performance of the KRS Private Equity allocation. Given there is not appropriate benchmark to use for short term performance evaluation, this will allow greater focus on longer term returns, which is more appropriate given the long term nature of private equity investments.

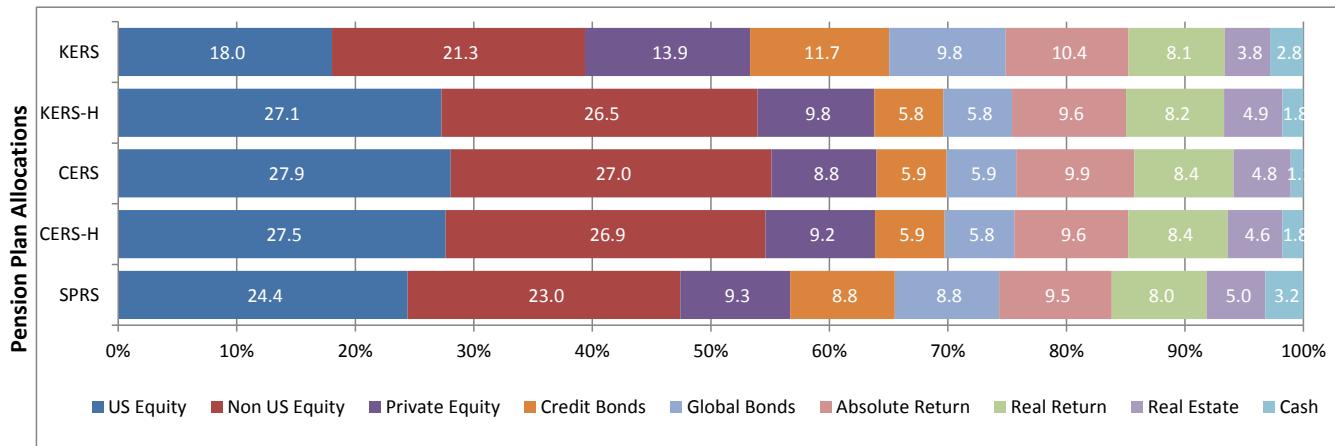
