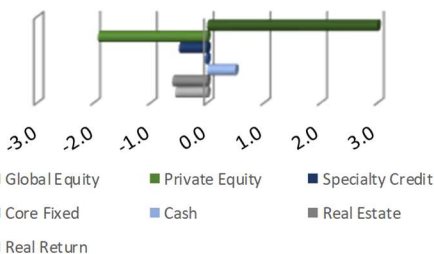

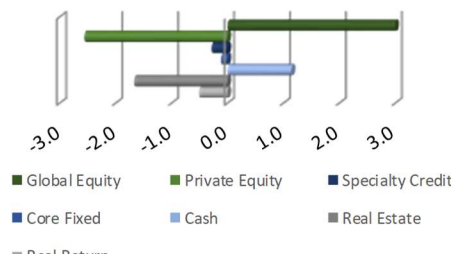

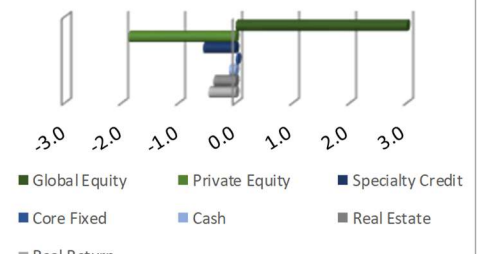
KERS PEN Relative Weights

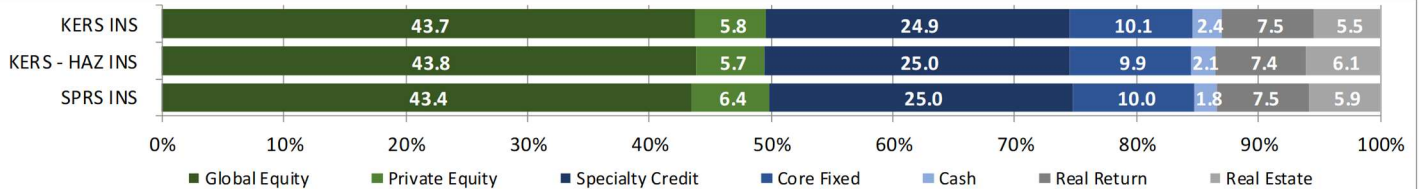

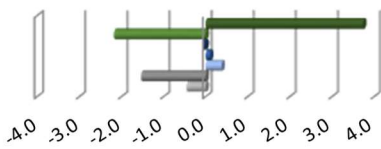

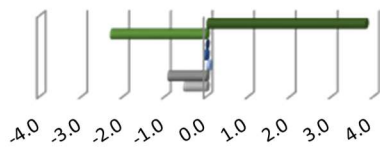


KERS Insurance Relative Weights



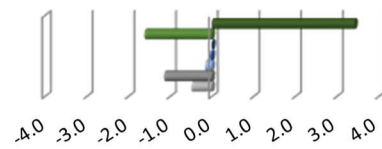
